BID NAME

Bid #2610 – Annual Dri-Water Cartons

BID DESCRIPTION

The County intends to purchase Dri-Water cartons for its mitigation plantings. Dri-Water cartons will be buried next to new plantings in remote or hard to reach locations, in order to provide the plants moisture during the dry summer months of the year.

SOURCE OF FUNDS

Funds for this purchase are coming from Clark County Capital Roads Fund.

BUDGET IMPACT

This material will be purchased as part of the Clark County mitigation program to reduce maintenance costs. The program already has a dedicated maintenance budget and the use of Dri-Water should reduce costs by improving maintenance efficiency.

ALTERNATIVES CONSIDERED

The remote nature of the mitigation sites and equipment limitations prompted the review of the Dri-Water alternative. The program budget is currently based on repeated seasonal hand watering events. This method stretched existing manpower and equipment to the limit, due to the small size of water-tanks available (which incurred considerable costs, due to the time lost in repeated trips to re-fill the water trailer). The Dri-Water alternative was reviewed for its maintenance efficiencies.

RECOMMENDATION

Environmental Services intends to award this bid to the lowest responsive bidder.

Purchasing received two responses for Annual Dri-Water cartons. The bids were checked for accuracy, content, and compliance to specifications.

Purchasing and Environmental Services recommend that Bid #2610, be awarded to the low bidder, Terra Tech, LLC of Eugene, OR in the total bid amount of \$36,422.40 including Washington State Sales Tax, and grant authority to the acting County Manager to sign all bid related contracts.
