Blair-Zeek Bridge Seismic Retrofit

Mike Westerman, Purchasing Manager read a memo stating Purchasing and Public Works recommends that the Blair-Zeek Bridge Seismic Retrofit be awarded to the low bidder, MH Hughes Construction of Vancouver, WA, in the total bid amount of \$294,101.00 including Washington State Sales Tax, and grant authority to the County Administrator to sign all bid related contracts. Madore praised the Public Works staff in getting a grant. Further discussion ensued.






