A joint resolution of the Boards of County Commissioners for Klickitat and Skamania Counties and the Board of County Councilors for Clark County relating to the appointment of trustees to the Fort Vancouver Regional Library.

WHEREAS, in 1952, Clark County and Skamania County formed an Interrural Rural Library District; and

WHEREAS, in 1973, the Intercounty Rural Library District was expanded to include Klickitat County; and

WHEREAS, in 1981, the City of Vancouver annexed into the Intercounty Rural Library District; and

WHEREAS, pursuant to RCW 27.12.130 and 27.12.190, the Boards of County Commissioners of the participating counties within the Intercounty Rural Library District are to appoint a board of trustees through joint action; and

WHEREAS, Clark, Klickitat, and Skamania counties have entered into an Interlocal Agreement setting forth the process for the appointment of trustees; and

WHEREAS, Clark County Representative Christopher O'Malley's term will expire on December 31, 2014; and

WHEREAS, Christopher O'Malley has confirmed his acceptance of reappointment to Position No. 7 as the Clark County designee; and

WHEREAS, it is the desire of the Board of County Commissioners of Klickitat, and Skamania counties and the Board of County Councilors for Clark County to reappoint Christopher O'Malley to Position No. 7, representing Clark County for a term terminating December 31, 2021.

NOW THEREFORE BE IT ORDERED AND RESOLVED by the Boards of County Commissioners for Klickitat and Skamania Counties and the Board of County Councilors for Clark County, State of Washington, that Christopher O'Malley is hereby reappointed to serve as trustee of the Fort Vancouver Regional Library as the Clark County designee for a term expiring December 31, 2021.
