**BACKGROUND:** WSU Extension and Clark County have a longstanding partnership. Clark County and Washington State University Extension have operated under a Memorandum of Agreement (MOA) first signed in 1989, and then updated in 2011. This new Interagency Agreement (IAA) sets out the framework for the strategic partnership between Clark County and WSU. The parties intend for this partnership to broaden, strengthen, and better leverage the existing and ongoing working relationship between the two entities. The IAA also serves as an umbrella document for the development of annual programming outcomes.

Appendix A is normally renewed annually and specifies the amount of funding appropriated by the County to operate the WSU Extension office, as well as contribute to salaries and wages of WSU faculty, educators, and program assistants. In establishing the funding level for the 2014 Appendix, Clark County estimated WSU Extension expenses through the end of 2013. However, Clark County paid expenses that came in after the Appendix A was finalized which totaled \$2,500. The amended funding total for 2014 is \$341,508.




