**BACKGROUND:**

This project will rehabilitate the substructure of Dayton Bridge, including repair of scour on existing abutments, bank stabilization and necessary environmental mitigation. Project funding includes a grant from WSDOT Highways & Local Programs Bridge Program (BRAC).

The construction documents are complete and we are ready to advertise the contract for bids. The advertisement is contained in the attached "Notice to Contractors".

**COMMUNITY OUTREACH:**

This project is included in the adopted 2013-2018 Transportation Improvement Program (TIP). Development of the TIP includes a wide array of public input opportunities, including public hearings, open house meetings, and an internet web page.

**BUDGET AND POLICY IMPLICATIONS:**



Dayton Bridge will receive scour repair, bank stabilization and any required environmental mitigation.

Total cost is estimated at \$440,572.

Description of work: Repair existing concrete footings, abutments and wingwalls. Install scour protection and plant mitigation.

All bids shall be delivered to the attention of the Clark County Purchasing, P.O. Box 5000, Vancouver, Washington 98666-5000 or 1300 Franklin Street, Suite 650. Bids shall be placed in a sealed envelope, marked "Sealed Bid", which clearly states the name of the bidder, the project number, the project title, the date of the bid opening, and appropriate wording to indicate definitely the nature of the contents. Do not send bids by FAX or email. Bids submitted by FAX or email will not be accepted.

A bid proposal deposit, made in the form of a certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of the bid proposal, shall accompany all bid proposals. Should the successful bidder fail to enter into such contract and furnish satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the Clark County Road Fund.

The right is reserved by the Clark County Board of County Commissioners to waive informalities in the bidding, accept a proposal of the lowest responsible bidder, reject any or all bids, republish the call for bids, revise or cancel the work, or require the work to be done in another way if the best interest of the Contracting Agency is served.


