BACKGROUND

This project will replace Fifth Plain Creek Bridge #230, located on NE 88th Street approximately 0.50 miles east of NE Ward Road. The current two-span timber bridge suffers from seismic deficiencies and will be replaced with a single-span concrete bridge meeting current seismic standards. Required environmental mitigation will also be performed.

Approval at this time will allow advertisement upon approval of federal construction funds, expected within the next two weeks.

ADMINISTRATIVE POLICY IMPLICATIONS

This project is part of the County's ongoing Bridge Repair/Improvement Program and Transportation Improvement Program.

COUNCIL POLICY IMPLICATIONS

IT IS HEREBY RESOLVED THAT **Fifth Plain Creek Bridge #230**

Located on NE 88th Street, approximately 0.50 miles E of NE Ward Rd.

State Road Log No. 52880 from Milepost 0.51 to Milepost 0.52 be improved as follows:

This project will replace Fifth Plain Creek Bridge #230, located on NE 88th Street approximately 0.50 miles east of NE Ward Road. The current two-span timber bridge suffers from seismic deficiencies and will be replaced with a single-span concrete bridge meeting current seismic standards. Required environmental mitigation will also be performed.

For the safety of construction workers and the traveling public, Clark County will close NE 88th Street in the vicinity of the bridge during construction. Coordination will be maintained with fire districts and emergency service providers, throughout the closure and during construction. This project is hereby declared to be a public necessity, and the County Engineer is hereby ordered and authorized to report and proceed thereon as provided by law.

IT IS FURTHER RESOLVED that an appropriation from the officially adopted road fund budget, and based on the County Engineer's estimate, is hereby made in the amounts and for the purposes shown:

NOTICE IS HEREBY GIVEN that sealed bids will be received until _____, by the Clark County Board of County Councilors through the General Services Purchasing Department, 1300 Franklin Street, Suite 650, Vancouver, Washington 98660, for the **Fifth Plain Creek Bridge #230, CRP No. 332422**; and other work; then publicly opened and read aloud at the Commissioners' Hearing Room, 6th Floor of the Public Service Center, 1300 Franklin Street, Vancouver, Washington 98660, at _____, or as soon thereafter as the matter may be heard.

Description of work: This project will replace Fifth Plain Creek Bridge #230, a Structurally Deficient two span concrete and timber bridge, with a single span precast concrete girder bridge. The replacement bridge will be approximately 70 feet in length and approximately 50 feet in width. Project will also include the necessary approach roadway work, stream work and environmental mitigation.

Primary bid items: Removal of structure and obstruction (including bridge removal); In-Water Work Isolation; Furnish & Drive Steel Piles; Superstructure – Fifth Plain Creek Bridge; Fabric Encapsulated Soil Lifts (FESL)

It is considered exempt from Freedom of Information requirements. All bids shall be delivered to the attention of the Clark County Purchasing, P.O. Box 5000, Vancouver, Washington 98666-5000 or 1300 Franklin Street, Suite 650. Bids shall be placed in a sealed envelope, marked "Sealed Bid", which clearly states the name of the bidder, the project number, the project title, the date of the bid opening, and appropriate wording to indicate definitely the nature of the contents. Do not send bids by FAX or email. Bids submitted by FAX or email will not be accepted.

A bid proposal deposit, made in the form of a certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of the bid proposal, shall accompany all bid proposals. Should the successful bidder fail to enter into such contract and furnish satisfactory performance bond within the time stated in the specifications, the bid proposal deposit shall be forfeited to the Clark County Road Fund.

The right is reserved by the Clark County Board of County Councilors to waive informalities in the bidding, accept a proposal of the lowest responsible bidder, reject any or all bids, republish the call for bids, revise or cancel the work, or require the work to be done in another way if the best interest of the Contracting Agency is served.




